## ORDER

In exercise of the powers conferred by the first proviso to sub-rule (5) of Rule 35 of the West Bengal Excise (India Made Liquor) Rules, 2010 published vide Excise Department Notification No. 1320-EX dated 12.11.2010, as subsequently amended, and in supersession of all earlier orders in this regard, the distributor, wholesaler and retailer margins for packaged India Made Liquor (IML) products are fixed as follows with effect from 14.08.2024:

\*AVM means "Admissible Value for Margins" and shall be as follows: -

- <u>AVM for Distributors</u> Sum total of Declared Price, Inventory Management Cost, Production Fee, Excise Duty and Additional Excise Duty and any other fee/cost allowed at the manufacturer/importer level.
- <u>AVM for Wholesaler</u>- Sum total of Declared Price, Inventory Management Cost, Production Fee, Excise Duty, Additional Excise Duty, any other fee/cost allowed at the manufacturer/importer level and Distributor Margin.
- <u>AVM for Retailers</u> Sum total of Declared Price, Inventory Management Cost, Production Fee, Excise Duty, Additional Excise Duty, and any other fee/cost allowed at the manufacturer/importer level, Distributor Margin and Wholesaler Margin.
