**G.S.R.07** .-Whereas the draft of the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licenses) (Amendment) Rules, 2024, amending the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licenses) 1973, in exercise of the powers conferred by section 41 of the Rajasthan Excise Act, 1950 (Act No. II of 1950), was published as required by sub-section (3) of section 41 of the said Act, in the Rajasthan Gazette Extraordinary part 4(C) G.S.R. 199 dated 13.03.2024 inviting objections and suggestions from all persons likely to be affected thereby before the expiry of 10 days from the date on which the copies of the said notification as published in Rajasthan Gazette were made available to the public;

And whereas, copies of the said notification were made available to the public on 13.03.2024;

And whereas, no objection & suggestion received on the said Draft Rules.

Now, therefore, in exercise of the powers conferred by section 41 of the Rajasthan Excise Act, 1950 (Act No. II of 1950), the State Government hereby makes the following rules further to amend the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licenses) 1973, namely:-

**1. Short title and commencement.**- (1) These rules may be called the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licenses) (Amendment) Rules, 2024.

(2) They shall come into force from 01<sup>st</sup> April, 2024.

**2. Amendment of rule 3.**-In table of sub-rule(3) of rule 3 of the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licences) Rules, 1973, the existing serial number 3 and entries thereto shall be substituted by the following, namely:-
