EXEMPTION OF STAMP DUTY UNDER SECTION 9(1)(a) OF THE INDIAN STAMP ACT, 1899 AND REGISTRATION FEE UNDER SECTION 78 OF THE REGISTRATION ACT, 1908 IN RESPECT OF THE CONSUMPTION LOANS UPTO Rs.50,000/-, RESCHEDULING LOANS AND FRESH NEED BASED LOANS SANCTIONED TO THE FLOOD VICTIMS ON OR AFTER 30.08.2024.

NOTIFICATION-I

In exercise of the powers conferred by clause (a) of Sub section (1) of Section 9 of the Indian Stamp Act 1899 (Act II of 1899), the Governor of Andhra Pradesh hereby remit the Stamp Duty in full chargeable on documents of Consumption loans upto Rs. 50,000/-, Rescheduling loans and Fresh Need based loans sanctioned by banks to the flood victims on or after 30.08.2024 in the flood affected Districts in the State of Andhra Pradesh i.e., 1.Vizianagaram, 2.ASR, 3.Kakinada 4.Eluru, 5.West Godavari, 6.Krishna, 7.Guntur, 8.Bapatla, 9.Palnadu and 10.NTR.

NOTIFICATION-II

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), The Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of fee" issued in G.O.Ms.No.463 Revenue (Regn.I) Dept., dated 17.08.2013 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(r), the following shall be added as 6(s) namely:

6(s) No registration fee shall be levied on documents of Consumption loans upto Rs.50,000/-, Rescheduling loans and Fresh Need based loans sanctioned by banks to the flood victims on or after 30.08.2024 in the flood affected Districts in the State of Andhra Pradesh i.e., 1.Vizianagaram, 2.ASR, 3.Kakinada 4.Eluru, 5.West Godavari, 6.Krishna, 7.Guntur, 8.Bapatla, 9.Palnadu and 10.NTR.

The Governor of Andhra Pradesh hereby exempt User Charges on documents of Consumption loans upto Rs.50,000/-, Rescheduling loans and Fresh Need based loans sanctioned by banks to the flood victims on or after 30.08.2024 in the flood affected Districts in the State of Andhra Pradesh i.e., 1.Vizianagaram, 2.ASR, 3.Kakinada 4.Eluru, 5.West Godavari, 6.Krishna, 7.Guntur, 8.Bapatla, 9.Palnadu and 10.NTR.

The above exemption of Stamp Duty, Registration Fee and User Charges shall be in force upto 31.03.2025.

This order issues with the concurrence of the Finance Department vide their orders at Note # 35, dated 14.10.2024 (Computer No.2573735).

The Commissioner and Inspector General of Registration and Stamps, A.P., Tadepalli shall take further necessary action accordingly.
