ORDER

Sub: Providing of electricity connections to EV charging station installed at outlets of Petrol Pumps/ CNG/ LPG stations up to load of 200 KW on LT supply voltage.

For providing of electricity connections to Electric Vehicle charging stations installed at outlets of Oil companies, a Comml.JDP/1061 dated 04.03.2024 was issued wherein load up to 200 KVA was allowed on LT supply voltage by installing Nigam's transformer outside the premises of Petrol Pumps and metering was allowed on LT side.

In supersession to above and in compliance of decisions taken in meeting of 88th DCF, it is ordered that-

1. The connection for load up to 200 kW with Contract demand above 50 KVA can be released on LT supply voltage for EV charging stations, installed at outlets of Petrol Pumps/ CNG/ LPG stations of oil companies, through Nigam's transformer to be installed outside the premises of petrol pumps with metering on LT side.
2. In such cases, transformer rent and transformation losses @3% shall be recovered as per provision of TCOS-21 (as amended) and Tariff for supply of electricity-2024.
3. On request of applicant, transformer may be supplied by Discom (on applicant cost) and in case of its failure within guarantee period, the same shall be replaced by the Discom on its own cost, however, on failure in beyond guarantee period, then same will be replaced by Discom by charging cost of transformer from the consumer as per latest SIR plus applicable Labour and Overhead charges, as per prevailing norms.

All concerned are directed to ensure compliance.
